

# If This is 2023, This Space will be about Abortion Petitions

This message is just in from Floridians Protecting Freedom.

We are now in the final months of collecting petitions and there is *no guarantee* that we will reach the 891,523 validated petitions needed to get the <u>Floridians Protecting</u>
<u>Freedom</u> (FPF) proposed amendment on the ballot.

Now, more than ever, we implore you to work the crowds at big events to collect as many petition forms as possible. This is the most efficient way to collect the most petitions in the shortest amount of time.

Collection events might be found on the <u>FPF events webpage</u>. You can also check your social media, the newspapers, and your friends to find other events where you can gather petitions. Anywhere where people are standing in lines is good. Anywhere where people are lounging in parks or other venues. Anywhere where there are people, basically.

If you haven't been out in the field yet, training for new petition collectors is held every week - <u>training registration link is here</u>.

# Hillsborough Libraries Keep Books on the Shelves

What began as a broad request to move or restrict access to materials that might be deemed inappropriate for minors has resulted in a plan to issue seven different library cards for minors.

Throughout this process, the HCPLC was committed to two key principals:

- Parent's rights and responsibilities in guiding the reading of their own children;
   and
- 2. Not removing, hiding or deselecting any materials outside of the established Request for Review process.

The following categories will offer parents a balance of access options to suit their needs.

Juvenile Library Cards (Ages 0-12)

- Juvenile Card: Default Card for ages 0-12 (incl. HAAL Pass). Access to all Juvenile materials.
- Juvenile Plus: Parents can opt to allow access to General Non-Fiction and Classics.
- Juvenile Unrestricted: Parents can opt for unrestricted library access.

#### Teen Cards (Ages 13-16)

• Teen Card: Default card for ages 13-16 (incl. HAAL Pass). Access to Juvenile materials plus YA Fiction, Graphic Novels, General Non-Ficton and Classics.

- Teen Restricted: Parents can opt out of YA Ficiton and Graphic Novels.
- Teen Plus: Parents can opt into R- or non-rated DVDs.
- Teen Unrestricted: Parents can opt for unrestricted library access.

Libraries will begin offering these new cards sometime in the first quarter of 2024. Let us thank our librarians for all they do for us. Library staff are awesome!

Susan Webb had passions, one of which was the League. As membership chair of the Hillsborough League 1980-81, she exceeded our goal of 100 members.

Susan's letters to prospective members persuaded them to join, a reflection of her eloquent writing and welcoming



Twenty years later, after Susan moved to Brevard County, she became president of the Space Coast LWV. Her longtime active involvement with the League, especially taking on the presidency later in life, was a reflection of her passion.

Susan was persuasive and persistent. She convinced the Hillsborough County Schools to let her daughter skip a grade and go to an IB High School at the age of 13.

Susan had opinions. She had a long career in social work and public health and she was very active politically, in political campaigns and in several Medicare for All and national health care groups. She tried to keep her friends politically informed by frequently forwarding news articles.

Susan Webb is survived by her husband of 48 years, John Twitchell, children Elizabeth and Charles Twitchell, and her sisters. To honor Susan, please donate to your local voting rights project.

## Impaled on Our Own Grid

Brooke Ward, the senior Florida organizer for Food and Water Watch, spoke at our Oct. 23 Member Mingle at Shuffle on Florida utilities. According to Brooke, utility costs are a social justice issue - those who can't afford energy-saving appliances and home repairs pay more for energy than those who can. In addition, monopolistic utility companies and the Florida Public Service Commission are keeping us in an endless cycle of dependency on fossil fuels. TECO, for example, has locked us into fossil fuels for the next 30 years by building the infrastructure to switch us from natural gas to fracked fuel. While other states are moving towards alternative energy, we are still relying on dinosaurs.

There's no hope that anything will change in Tallahassee in the near future, but local governments can help with block grants and we can all do our part with climate justice activities. Pay attention to the 2024 county elections, says Brooke.

Our utility companies, by the way, include in the base rate they charge us fees that they then use to pay lobbyists to write laws that cost taxpayers more money and also enable utility company executives and shareholders to receive hefty payments.

The White House announced on Oct. 3 that Medicare is now able to negotiate directly the prices of prescription drugs due to President Biden's prescription drug law, the Inflation Reduction Act. Negotiations with participating drug companies for the selected ten drugs will occur in 2023 and 2024 with the negotiated prices effective beginning in 2026.

Future Member Management System

The US League of Women Voters voted at the last convention to better meet the needs of local, state, and national league levels. The change that will be most apparent to us is the transition to a new member management system. With input from members across the country, the application ChapterSpot was selected as the new, mandatory membership platform. The transfer to the new system will take place over the next year, with training and implementation after the 2024 elections.

The changes (as described so far) include:

- A "one-stop shop" for new members and current members renewing their League memberships.
- New members will select the local and state chapters they wish to join.
- Paper forms and checks will still be accepted, but will have to be entered manually by the local league.
- Auto-renewal will be available as an option. The system will automatically notify members when it is time for renewal.
- The membership year will be rolling month-to-month
- There will be a pay-what-you-can option (\$20 minimum is suggested); the standard rate will be \$75 for an individual. There will be higher tiers for those who wish to make an additional contribution. The "contribution" will be split between national, state, and local levels in the same proportion as the dues. This means that local leagues will no longer be able to keep the entire amount paid over and above the standard rate. Household membership will be available at \$112.50 per household.
- Credit card fees will be split between local, state, and national Leagues at the same percentage as the dues.
- LWVUS will receive 33% of dues payments, a decrease of 18% from current amount. The state league will receive 47% of dues.
- There will be no student memberships.
- There will still be lifetime memberships (more than 50 years).
- Leagues can continue to use their existing websites. A link will have to be added to the national site for membership.

I will request a review of the financial impact of this new system on our own league once we have enough information to conduct the analysis. This information will be used to construct our 2024-25 proposed budget.
