Happy April! Thank you to our members who volunteered for events in March. As mentioned in our 'Take Action' notice last week, there are opportunities this week to speak out in support on two very important issues: the Hillsborough County election process & Hillsborough County Public Schools. As you may know, Pasco County was successful in passing a millage referendum for teacher salaries in 2022. Hillsborough County Public Schools is still trying. Here are quick ways to take action if you haven't already:

The Hillsborough Board of County Commissioners (BOCC) will hold a public hearing on Wednesday, April 3rd at 10 am to discuss their vote to reduce the Hillsborough Supervisor of Election's budget by \$200,000. Help us urge BOCC members to support fully funding our election process in an election year.



### **Urge Local Leaders to Rein in Electric Rates**

Our League, through our Environmental and Climate Change Action Group, has partnered with the Affordable Energy Coalition to work with local and state government leaders to reduce the cost of energy, and to increase the use of sustainable power sources in Hillsborough County.

The increasing amount of our income we spend on paying for electricity is a major driver of rising consumer costs. In fact, in the last four years, the average Tampa Electric (TECO) bill has gone from \$99 per month to \$162 per month. That's an additional \$756 per year! These costs keep going up because utilities refuse to quit their fossil fuel addiction. Between international conflicts and corporate greed, the costs of fossil fuels are volatile and ever increasing. And in Florida, the costs of fuel are passed directly on to Florida families.

It's time to urge our elected officials to do something about it! A few months ago, thirteen Hillsborough residents, including League member Steve Kauffman, showed up at a Hillsborough County Board of Commissioners meeting and asked them to fight to give us a voice in TECO rate hike hearings... and they responded by sending a letter to bring TECO rate hearings from Tallahassee to Hillsborough.

Our local leaders can do even more. In Hillsborough County, the county commission can pass policies to increase access to solar, improve energy efficiency (less energy used means lower bills), and invest in resiliency. And we have the power to make them do it!

Send a message to the Hillsborough County Commission to tell them to act on our rising bills. We know they can make a difference if they take action.
